

Main Characteristics of HC

- One unique organization (belongs to MEPP & PWs)
- Title registration positive cadastre
- Adjudication process
- Fully digital

The stretch of the HC refers to the total of 131,600 km²

(country's surface)

ADJUDICATION PROCESS

- Cadastral Survey / Declarations, Submission
- Compilation of temporary cadastral maps & records
- "Display" of maps & records mail a copy to the owner
- Objections submission
- Examination and trial of objections
- Amendment of temporary maps & records
- Second "display" mail a copy
- Recourses
- Examination and trial of recourses
- Second amendment of cadastral data
- First Registration recovery fees
- Five year time limit for disputes of correctness
- Validation of First Registration Title of the Land (permanent proof, "unknown ownership" → Public)

PROGRESS OF THE HC PROJECT

1994 Proposal – Original Action Plan

2001 Evaluation of the Strategic &Business Plan

Compilation period until 2014

Total estimated cost 1.76 billions EUR

(rate 2000) for the compilation

POINTS THAT JUSTIFY THE NEW FINANCIAL ESTIMATION

- 1. At 1994 there was lack of accurate statistical data:
 - Existing urban areas are 30% more than what was estimated according to the National Statistical Service of Greece during the 1991 census
 - Legal rights are 70% more than those estimated

- 2. Need for additional necessary works, such as:
 - Compilation of forest maps
 - Mail of cadastral data (part of the map sheet and table) to each owner
 - Updating and maintenance of the cadastral data by the contractors (private surveyors and layers) during the compilation period



1.	Compilation of cadastral maps	13.5 %
2.	Collection and processing of legal rights	66.5 %
3.	Compilation of forest maps	7.5 %
4.	Operational cost of the private surveying offices	6.5 %
5.	Preparation of cadastral sheets and mailing cost	6.0 %

This cost constitutes the 85% of the total cost for the compilation of the HC. The rest refers to the cost for the quality control of the CS's and the operational cost of the two type committees for the objection's examination.

POINTS THAT JUSTIFY THE CHANGE IN THE TIME SCHEDULE

- First two phases of Cadastral Surveys Pilot Schedule
- Administrative issues establishment of KT in 1996
- Enormous involvement of individuals
 - During the three phases 2,500,000 persons submitted declarations for 5,000,000 legal rights
- Great delay in the objections examination of the first pilot phase

- 78% are declarations for full ownership
- 7% are declarations for naked ownership
- 7% are declarations for usufruct
- 1% are declarations for servitude
- 6% mortgages
- 89% are declarations accompanied with titles (deeds)
- 11% are declarations with no documents
- 0.3% of urban real estates had "double" declarations
- 2% of rural real estates had "double" declarations

In total we had "double" declaration for 30.000 real estates so far

STATISTICAL ANALYSIS

OF 2.100.000 DECLARATIONS FOR 4.350.000 LEGAL RIGHTS

- 96% declarations submitted within the fixed term
- 4% declarations submitted out of time
- 97.9% declarations submitted by individual citizens
- 1.96% declarations submitted by "legal Persons"
- 0.03% declarations submitted by the State (not obligatory)
- 0.01 declaration submitted by the Orthodox Church
- 48% of the real estates belong to men
- 52% of the real estates belong to women
- 5% of the citizens who declared legal rights live abroad
- 47% of the citizens who submitted declaration have more than 1 ownerships

PUBLIC ACCEPTANCE

Positive attitude

• March 1999: 80% of the citizens

• December 1999: 83% of the citizens

Willing to submit a declaration

• December 1999: 93% of the citizens

ADVANTAGES OF THE HC (according to the public opinion)

- 74% Believe that the HC will help the control of illegal building
- 61% Security of land tenure no boundary disputes
- 54% Security of public land
- 49% Title system
- 37% Improve the land market
- 33% Protect the forest land
- 18% Development of national resources policy
- 16% Diminish the bureaucracy
